

# 2021 Theme: Recovering better for an equitable and sustainable world

From: the UN International Day of Peace

Each year the International Day of Peace is observed around the world on 21 September. The UN General Assembly has declared this as a day devoted to strengthening the ideals of peace, through observing 24 hours of non-violence and cease-fire.

In 2021, as we heal from the COVID-19 pandemic, we are inspired to think creatively and collectively about how to help everyone recover better, how to build resilience, and how to transform our world into one that is more equal, more just, equitable, inclusive, sustainable, and healthier.

The pandemic is known for hitting the underprivileged and marginalized groups the hardest. By April 2021, over 687 million COVID-19 vaccine doses have been administered globally, but over 100 countries have not received a single dose. People caught in conflict are especially vulnerable in terms of lack of access to healthcare.

In line with the Secretary-General's appeal for a global ceasefire last March, in February 2021 the Security Council unanimously passed a resolution calling for Member States to support a "sustained humanitarian pause" to local conflicts. The global ceasefire must continue to be honoured, to ensure people caught in conflict have access to lifesaving vaccinations and treatments.

The pandemic has been accompanied by a surge in stigma, discrimination, and hatred, which only cost more lives instead of saving them: the virus attacks all without caring about where we are from or what we believe in. Confronting this common enemy of humankind, we must be reminded that we are not each other's enemy. To be able to recover from the devastation of the pandemic, we must make peace with one another.

And we must make peace with nature. Despite the travel

And we must make peace with nature. Despite the travel restrictions and economic shutdowns, climate change is not on pause. What we need is a green and sustainable global economy that produces jobs, reduces emissions, and builds resilience to climate impacts.

The 2021 theme for the International Day of Peace is "Recovering better for an equitable and sustainable world". We invite you to join the efforts of the United Nations family as we focus on recovering better for a more equitable and peaceful world. Celebrate peace by standing up against acts of hate online and offline, and by spreading compassion, kindness, and hope in the face of the pandemic, and as we recover.

#### Background

The International Day of Peace was established in 1981 by the United Nations General Assembly. Two decades later, in 2001, the General Assembly unanimously voted to designate the Day as a period of non-violence and cease-fire.

# Taliban takeover highlights failure of war to bring democracy, say pacifists

British pacifists have condemned the Taliban as well as the US and UK governments for the situation unfolding in Afghanistan.

The Peace Pledge Union (PPU) said that the Taliban's return to power after 20 years of NATO military action had made clear that democracy cannot be brought about with bombs and guns.

The PPU made clear that their first thoughts today are with the people of Afghanistan facing the horrors of renewed Taliban rule. They expressed their concerns for the Afghan Peace Volunteers, a pacifist community in Kabul who oppose both the Taliban and NATO forces.

The PPU was among the many groups to campaign against the US-led invasion of Afghanistan in 2001.

Today they pointed out that the Taliban have been using the US-led military occupation of the country to justify their own violence. In the same way, the US government of George W. Bush used the horrific killings of '9/11' to justify killing an even greater number of civilians in Afghanistan.

The PPU insists that, "Militarism anywhere encourages militarism everywhere".

"The lies used to justify war are ringing hollow today," said the PPU's campaigns manager Symon Hill. "Thousands of lives have been wasted in war: the 457 British forces personnel killed, the other NATO troops who died with them, the much greater number of Afghans killed, shamefully uncounted by the western authorities."

Commenting on the billions of pounds spent on war in Afghanistan since 2001, the PPU suggested that the money could have been better spent building up health care, education, infrastructure and civil society in Afghanistan. This would have considerably weakened the Taliban's recruiting appeal, based on calling for resistance to US occupation.

The PPU slammed the hypocrisy of successive UK governments and military leaders for using talk of democracy to justify wars and destruction that may have had more to do with strategic and commercial interests, and loyalty to the US establishment.

The PPU's Symon Hill added, "While British ministers rightly condemn the Taliban, they continue to sell arms to equally vicious regime of Saudi Arabia. British armed forces are providing training to the Saudi forces killing civilians in Yemen. Real support for democracy involves long-term international solidarity against war and injustice, not the perpetuation of cycles of violence."

The Peace Pledge Union is the British section of War Resisters' International, which unites pacifists and anti-militarists around the world.



## **Afghanistan**

Events are happening very fast in the world today but perhaps none faster than the rapid advance of the Taliban and the fall of the US puppet regime in Afghanistan. It is reported that Afghan President Ashraf Ghani fled the country with four cars and a helicopter full of cash.

Perhaps we were not prepared for the rapid fall of the US supported Afghan government and forces because we have not been told the truth throughout the 20-year occupation and war. The US supposedly went into Afghanistan to capture Osama Bin Laden who they held responsible for the attacks on 9/11. The Taliban government said they would turn him over to an international court if shown proof of his involvement, but rather than do that, the US attacked and occupied the country and turned the government over to a group of war lords from the Northern Alliance. That was supposed to bring democracy to Afghanistan. Twenty years later the Taliban has returned stronger than ever.

It has to be clear that the Taliban have a lot of support in Afghanistan because they took the entire country at lightning speed. They have no Air Force, no advanced weaponry or intelligence. The Taliban are not from outside the country, they are a home grown movement. So why do they have such support? The answer is that they have been the main force in the country that has been resisting the occupation of the US and its Western allies, and the Afghan people, like all people, do not like to be occupied. The last 20 years have been hell for the Afghan people.

Around 240,000 have been killed, there have been massive numbers of drone strikes and bombings, Black sites for torture such as Bagram Air Base were created. Opium production skyrocketed under the US occupation and 72% for the population lived at or below the poverty level. In a survey reported by the Associated Press in January 2020, only 33% of the people surveyed wanted the US to stay in their country. In another poll, 80% of Afghans said they feel fear when encountering the foreign occupation forces.

There has been a lot of talk about the puppet government supporting women's rights, but this is a sham. According to Afghan activist Malalai Joya, speaking on Democracy Now in July, "the catastrophic situation of the women of Afghanistan was a very good excuse for U.S. and NATO to occupy our country. Unfortunately, they pushed us from the frying pan into the fire as they replaced the barbaric regime of the Taliban with the misogynist warlords... That's why today millions of Afghans are suffering from insecurity, corruption, joblessness, poverty. And still, most of Afghan women are the victims." Several years ago, the United National Antiwar Coalition (UNAC) organized a US tour for Malalai Joya.

The US was never in Afghanistan to fight terrorism or to bring a better life for the Afghan people; they were there to install a pro-US government that would support their strategic political and military goals in the region including their aggression against China and Iran.

Additionally, they wanted to get their hands on the vast mineral resources in Afghanistan. If the US was interested in helping people in other countries, they would not be supporting despotic regimes such as those in Saudi Arabia, Haiti, Columbia, Israel and many others.

Now that the US has been defeated in Afghanistan, we can be sure that they will impose additional sanctions to make the people of that country suffer more and push for a regime change through which they can start the entire process over again. The continued US bombing in areas that fell to the Taliban was responsible for the killing of many civilians causing people to flee and the destruction of schools and health centers. We must demand: No more bombing, remove all troops, mercenaries, and special forces from the country and the surrounding area, no sanctions, and pay reparations for the destruction caused by their war and occupation. The people of Afghanistan must find their own way free from US intervention.

We are a group of scholars, researchers and experts on Canadian foreign policy. We are joining forces to urge all federal parties to recognize the importance of foreign policy issues and international affairs in this summer election campaign. Beyond pocketbook issues, a credible conversation on Canada's interests and role in the world is a necessary part of what will inform voters.

This election coincides with a critical moment for Canada's role on the global stage. A series of challenges from near and afar have had direct impacts on the jobs, safety, and livelihoods of Canadians. In a rapidly changing global context, Canada's security and prosperity will be contingent on how its political parties define and enact its foreign policy.

Turbulence in the Canada-US relationship, which began under the Trump administration but has not entirely abated under Joe Biden, signals the dawn of an era of unpredictability which should overturn traditional Canadian assumptions about foreign policy and the international order. Similarly, the rise of China will have implications for Canada's interests in ways that will be difficult to anticipate.

A multipolar world framed by an accelerating contest between great powers will impose constraints on Canada's ability to define and secure its interests as a sovereign country. With the arrival of the COVID-19 pandemic, it is even more clear that Canadian life is inextricably linked to global affairs.

It is imperative that the next government articulate Canada's voice on foreign policy issues and how it will navigate its international relationships in the years ahead. Canada's failed bid for a UN Security Council seat, its second in a decade, indicates that its global presence may already be waning. With the international order in flux, Canada needs a strategy to meet the challenges of the 21st century. If Canada continues to marginalize the vital role of foreign policy discussions at home, it risks diminishing its ability to secure its way of life and prepare for an increasingly uncertain world.

Amid this backdrop, we call on representatives from Canada's federal parties to participate in foreign policy debates, to recognize the importance of foreign policy in securing Canada's welfare, to raise the relevance of foreign policy issues where necessary, and to express strategically minded visions for Canada's role in the world during this election campaign.
